In Honor of Daniel J. Duann, Ph.D.


- WHEREAS,** Dr. Daniel Duann who retired on October 31, 2025, began his public service at the Ohio Consumers' Counsel in 2008; and

tireless efforts and lasting contributions of **Dr. Duann** to the agency and to Ohio's residential utility consumers.


